- 2. Sealed tenders will be received and opened in Committee Room WASA Main Office Jail Road Faisalabad on 05-03-2018. Bids receiving time is 12:30 P.M & Opening time is 01:00 P.M.
- 3. Only duly authorized representative of the contracting firms can purchase / receive tender documents on showing of Valid Renewal of Firm, PEC License & National Identity Card in Original.
- 4. Earnest money must be accompanied with the tender which should be valid for at least Sixty (60) Calendar days from the date specified for opening of the bids otherwise the same will not be entertained. Conditional tenders will not be entertained.
- 5. All the work will be carried out strictly according to PHE, B & R specifications to the entire satisfaction of the engineer in charge.
- Tenders shall be opened in the presence of interested bidders or their representatives who may care to be present.
- Procedure of open competitive bidding for serial No. 5 i.e. Single Stage One Envelope System shall be adopted.
- 8. If clarification and amendment in the bid is needed before the date of bidding, addendum to this effect can be issued even one day (24-hours) before the tender opening date / time.

- J. The bidder shall include all taxes and duties in the bid price.
- 4. The bidder will submit the bid in two parts; the first part shall be for specification, called the "technical bid", the second one for cost called the "financial bid". These bids should be in sealed envelopes and be submitted separately.
- The technical bid will be opened first and evaluated. If the specifications of the bid meet the requirement of bid document, then bid will be qualified for opening of financial bid, otherwise the same shall be returned unopened.
